

ATHLETE Nomination Form

The Volleyball BC Hall of Fame honours athletes, teams, coaches, officials, and builders who have had a significant impact on volleyball in British Columbia. Inductees exemplify the best in the history of the sport in our province.

Selection Process

- Nominations for induction in the following calendar year are accepted until Wednesday, September 30th.
- Any individual or association may submit a nomination with the following exceptions:
 - o A current Member of the Volleyball BC Hall of Fame Selection Committee may not submit a nomination.
 - A member of the Volleyball BC Board of Directors may submit a nomination, but if the Director submits a nomination, she or he may not vote on that nomination if and when it is brought to the Board of Directors for approval.
- Aside from the Team category, nominations will be accepted for individuals only. Family members or colleagues
 who worked together closely are eligible for induction within the same year or in subsequent years. However,
 each nominee will be considered separately on the basis of her or his own individual merit, and if selected will
 be inducted individually.
- Each nomination is eligible for three (3) consecutive years. If at the end of three (3) consecutive years of eligibility, a nomination has not been selected for induction, the nomination must sit inactive for a period of one (1) year after which the nomination can be resubmitted.
- All nominations will be considered at an initial Awards Committee meeting in October. Depending on the outcome of that process, further information on the nomination may be required.
- The final selection process will take place in October and the names will be released to the media in November.

Selection Criteria

Athlete Category

- A British Columbian athlete, or an athlete who played for a team that was based in the Province of British Columbia at the time of accomplishment(s).
- Any athlete of any discipline (indoor, beach, or sitting volleyball) who has brought recognition or honour to
 volleyball on a national or international level in relation to participation in open level sport(s) competition.
- Accomplishments that may be considered include, but are not limited to:
 - Canadian National Championships at all levels.
 - Canada Games participation and success.
 - o CCAA/CIS/NCAA All-Canadian and/or Player of the Year Status.
 - o World University Student Games participation and success.
 - National Team participation and success (such as, Pan Am or ParaPan Games, Commonwealth Games).
 - o World Championship and/or Olympic or Paralympic participation.

Exceptions:

- An individual is not eligible for nomination until three (3) years following retirement from open level sport(s) competition, except in the event of death or by winning an Olympic or a World championship gold medal whereby the nomination is eligible for immediate consideration.
- An individual retired for a period of three (3) years from open level sport(s) competition, but still competing in Seniors or Masters competition is eligible for consideration.
